## ... offers fondly care:

by a permanent contact person



for up to five children in day care

for children aged  
0 to 14 years



in a family-like  
environment

based on the needs of the parents

with flexible care times



## ... is:

- an equivalent offer to the kindergarten
- fondly care, upbringing and education from a qualified childcare worker
- cooperative interaction with parents
- supported by public funds

## ... enables the care:

- in the childcare provider's household
- in the parental household (so-called „nanny“)
- in a large day care center (group of two to three childcare workers)

## ... also means:

- the collection of an income-dependent parental contribution
- early contact with local childcare offices to arrange the formalities

## ... is supported by:

the local child day care offices  
in the form of

- arranging your child or children for care by a suitable childcare worker
- qualified advice and support in educational, financial and legal issues
- ensuring the quality of childcare



The specialist office for child day care in the  
youth department of the Gütersloh district in  
the form of

- cooperation with local childcare offices
- suitability test of childcare workers
- granting of permission to provide childcare in accordance with section 43 of the Social Security Code VIII, provided that the childcare worker meets the requirements
- financial support on a case-by-case basis for the childcare worker if the requirements are met
